Such personal data collected and that will be treated does not affect the most intimate sphere of its owner, nor does its improper use give origin to any discrimination, or entails any serious risk, expressly noting that no sensitive personal data will be treated, in accordance with Article 9 of the Federal Law on Protection of Personal Data.

- 4. If your request requires an alternative or different procedure to the one already mentioned, our department will inform you at the time of the response to the request made, in addition you will be informed of the appropriate procedure to your request.

Any subsequent modification or change to this Privacy Notice will be notified to the last email provided by the holder, and in turn published for consultation on the website: www.konoike-mexico.com.mx, to which the holder is in full capacity to access periodically to analyze such possible changes and / or updates.

The holder of the personal data that will be processed may appeal to the Federal Institute of Access to Information and

Data Protection, when he/she considers that his/her right to the protection of personal data has been violated.
